Background Checks: Volunteer Program Application

- I. **Checks Required**—In order to ensure the safety of our clients and staff, we require the following background checks for all incoming volunteers:
 - i. **Federal Criminal Background Check and OIG check** via our background check provider In-N-Out Screening Services (NOSS) (attached)
 - ii. **Arkansas Adult Maltreatment Registry Check** (complete by visiting https://ardhs.formstack.com/forms/daabh_adult_maltreatment_check)
**Please select either “Non-Profit” or “Volunteer” for the agency as there is no charge.
 - iii. **Arkansas Child Maltreatment Registry Check** (complete by visiting https://ardhs.formstack.com/forms/dcfcs_central_registry_request_v2)
**Please select the following answer for the first question: “None of the above applies, but you would like a registry check.”

- II. **Forms**—Each form (NOSS, Child Maltreatment Check, and Adult Maltreatment Check) must be completed in its entirety. Forms with missing fields will not be accepted. The two maltreatment forms must be notarized (a service offered by most banks at no charge to customers). Please note the two maltreatment registry check forms are filled out online and a printable copy will be emailed to you for printing and notarizing. - III. **Cost**—**Background check fees are \$16.00.** In order to off-set these costs, we ask all prospective volunteers cover this cost. I further understand this information may be reviewed initially and periodically by N Out Screening Services, Axiom, ClearStar Logistics and reported to my prospective employer.</p> <p>I understand my prospective employer intends to utilize the investigation into my background for employment purposes only, and shall not disclose such information to any other party. I hereby acknowledge that N Out Screening Services, Axiom, ClearStar Logistics and affiliated 3rd Party reporting agencies cannot vouch for or guarantee accuracy of information provided by third parties. Accordingly, I release N Out Screening Services, Axiom, ClearStar Logistics and affiliated 3rd Party reporting agencies and / or my prospective employer from any and all liability arising out of any errors or omissions regarding my background information and authorize N Out Screening Services, Axiom, ClearStar Logistic and affiliated 3rd Party reporting agencies to release the results of its investigation to my prospective employer.
